BYLAW NO. 2025-07

**A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT FOR
COMPENSATION FOR ASSESSMENT AND COLLECTION OF TAXES
WITHIN THE LAC PELLETIER REGIONAL PARK**

The Council of the Rural Municipality of Lac Pelletier No. 107 in the Province of Saskatchewan enacts as follows:

- 1. The Rural Municipality of Lac Pelletier No. 107, is hereby authorized to enter into agreement with the Lac Pelletier Regional Park Authority, the terms of which are attached hereto and marked Exhibit “A” for the purpose of establishing compensation to the Rural Municipality of Lac Pelletier No. 107 for costs related to assessment and collection of taxes within the Lac Pelletier Regional Park.
- 2. The Reeve and the Administrator of the Rural Municipality of Lac Pelletier No. 107 are hereby authorized to sign and execute the agreement, the terms of which are set out in Exhibit “A” here before referred to.
- 3. Bylaw No. 2023-16 is hereby repealed.

EXHIBIT “A”
MEMORANDUM OF AGREEMENT

This Agreement made in Duplicate this 8th day of August, 2023.

BETWEEN:

The Rural Municipality of Lac Pelletier No. 107, in the Province of Saskatchewan, a Municipal Corporation hereinafter referred to as **the “Municipality”**

AND:

The Lac Pelletier Regional Park Authority, in the Province of Saskatchewan, hereinafter referred to as **the “Regional Park Authority”**.

The Municipality shall levy the rate established by the Regional Park Authority, pursuant to Section 302(2) of the Municipalities Act, and
The Municipality agrees to forward to the Regional Park Authority, 100% (one hundred percent) of the Property Taxes levied, on behalf of the Lac Pelletier Regional Park Authority, and actually collected by the Municipality, within the Lac Pelletier Regional Park, pursuant to clause 302(7)(b) of the Municipalities Act.

Therefore, the Regional Park Authority agrees to pay to the Municipality:

- 1. The sum of \$3,350.00 (three thousand three hundred and fifty dollars) for the year 2026, for costs incurred by the Municipality for the assessment of property, levy of taxes and collection of taxes within the Lac Pelletier Regional Park. The said sum is due and owing by the Regional Park Authority to the Municipality on or before October 31, 2026; and
- 2. The sum of \$3,350.00 (three thousand three hundred and fifty dollars) for the year 2027, for costs incurred by the Municipality for the assessment of property, levy of taxes and collection of taxes within the Lac Pelletier Regional Park. The said sum is due and owing by the Regional Park Authority to the Municipality on or before October 31, 2027.

This agreement shall remain in effect for the years 2026 and 2027.
